## Launch of the RECON Online Working Paper Series

RECON has established an online working paper series for the publication of pre-print manuscripts on democracy and the democratisation of the political order in Europe.

The working paper series is interdisciplinary in character, but is especially aimed at political science, political theory, sociology, and law. It publishes work of theoretical, conceptual as well as of empirical character, and it also encourages submissions of policy-relevant analyses, including specific policy recommendations. The focus is on the study of democracy within the multilevel configuration that makes up the EU.

The series publishes work from the researchers involved in the project, but it is also open to submissions from other researchers working within the fields covered by RECON.

The first three papers in the series have been published. The first paper 'Europe in Transformation', by Erik O. Eriksen and John Erik Fossum is the framework paper for the RECON project. The second paper, by James Bohman offers a theory of democratisation for transnational polities. In the third paper, Christian Joerges claims that international trade law remains thin, and that it does not provide a framework for ensuring democratic legitimacy.

Since the launch of RECON in January, some of the work packages have held their kick-off workshops.

### RECON Kick-off Conference Oslo, 26-27 January 2007

ARENA hosted the project's kick-off conference in Oslo in January, where all researchers in the consortium met as a whole for the first time. The two-day conference addressed the main problems regarding supranational governance and democracy in Europe and presented the main themes of the project.

The first day of the conference was an open event that attracted some 160 people; researchers from Norwegian and European institutions, coordinators of other projects within the Sixth Framework Programme, as well as policy makers, practitioners, and representatives of civil society.

Norwegian State Secretary Liv Monica Stubholt held an opening speech on 'Democracy in the Age of Globalisation'. This was followed by an introductory speech by RECON's scientific coordinator Erik O. Eriksen.

Keynote speeches were held by John Dryzek, one of the leading political scientists on democracy beyond the nation state, and James Bohman, prominent theorist in the field of normative political theory and cosmopolitanism. Hauke Brunkhorst and Rainer Forst commented on their speeches. After lunch, John Erik Fossum, RECON substitute coordinator chaired the sessions where the RECON work package leaders presented the project's research fields. The sessions included comments by Tanja Hitzel-Cassagnes and Philippe C. Schmitter, and were followed by a final discussion. Angela Liberatore from the European Commission gave a presentation at the opening of Day II on 'RECON in a Framework Programme perspective', which was followed by a session on project management, communication and dissemination, and then smaller, parallel project meetings.

### Workshop: Re-framing Transnational Governance

Florence, 9 March 2007

Under the heading 'Re-framing Transnational Governance' the first WP 9 workshop took place on 9 March 2007 at the European University Institute (EUI) in Florence. The workshop was organised by Christian Joerges from the Department of Law at the EUI, and the event was held in conjunction with a workshop of the University of Bremen coordinated project 'Transformation of the State' which took place on 8 March 2007. Researchers from universities in Birkbeck, Bremen, Chicago, Frankfurt, Hamburg, London, Mannheim, Oslo and the EUI participated at the workshop.

The overall objective of WP 9 – Global Transnationalisation and Democratisation Compared is to examine how globalisation and transnationalisation processes shape the conditions for democracy within and beyond Europe, and to compare the European case with certain particularly relevant non-European instances of democracy and democratisation.

The workshop was a preliminary exercise aimed at framing the future work of WP 9. The first of three sessions dealt with meta-discourses on transnational law and was aimed at mapping the current theoretical debate on transnational law. The second session dealt with transnational product and process regulation and provided an opportunity for exploring developments within specific areas of transnational market regula-

tion, also with a focus on the World Trade Organization (WTO). In the third session, John Erik Fossum linked the work of WP 9 to WP 2 - Constitutional Politics, and focused on comparative aspects of transnational democracy.

### Workshop: Reconstituting Democracy from Below - New Approaches to Civil Society and the Public Sphere Bremen, 17-19 May 2007

The first workshop in WP 5 - Civil Society and the Public Sphere took place from 17 to 19 May 2007

at the Hanse Wissenschaftskolleg in Delmenhorst close to Bremen. The workshop organized by Ulrike Liebert (Jean Monnet Centre for European Studies, Bremen) and Hans-Jörg Trenz (ARENA, Oslo) and brought together some fifty researchers from across Europe, in-

cluding Russia, and from the US.

Prof. Sidney Tarrow (Cornell University) opened with a keynote on the possibility of an European civil society in a neo-Polanyian theoretical per-

spective. This was followed by 22 paper presentations in four subsequent panels: (I) Reconstituting democracy from below: European experiences; (II) Constituting a European public sphere: Innovative approaches media, communication and dis-

course analysis; (III) Civil society and democracy in Europe: Theoretical approaches and empirical methodologies; and (IV) Quantitative-qualitative methodology of media discourse analysis: Research training unit for national media analysts.

The workshop had three major objectives. First, to take stock of current and previous international research projects on both civil society and the public sphere (Europub, Civgov, Cinefogo, Connex, Emediate, EIF/Vienna, ConstEPS, ESF, and others). Second, the establishment of closer cooperation and exchange within the research group, and preparation of the Bremen Summer School (see box to the right). Third, to plan future cooperation with the subproject WP 8 – Identity Formation and Enlargement.

### Summer School: Advanced Methods and Techniques in Media Analysis Bremen, 22 July - 17 August 2007

The University of Bremen will organise and host a four-week Summer School on advanced methods and techniques in media analysis in July/August. The summer school is part of the subproject WP 5 - Civil Society and the Public Sphere in RECON and focuses on media discourse analysis using the software Atlas.ti.

The Bremen Summer School will provide a hands-on guided research training, including introduction to the methods used for data production and management, and how to link these to the analysis of theoretically relevant research questions. Participants will learn how to apply a theory-driven research agenda (code book) to their empirical research design for single-country media studies, as well as how to write up and present the results within a framework of systematic cross-country comparative research. Each participant will do original research on selected print media in one of fifteen languages (Czech, Danish, Dutch, English, French, German, Hungarian, Italian, Latvian, Polish, Portuguese, Romanian, Russian, Spanish and Swedish), and will produce a report with his/her research findings with the aim of publishing in the RECON report or online working paper series.

The Summer School is aimed at PhD students and experienced researchers who want to refresh and deepen their knowledge of media analysis. Please note that deadline for application has passed and that the Summer School is fully booked.

### NEW BOOK: The Anarchy of Communicative Freedom

Under conditions of globalisation it is no longer possible to conceive of international politics as only a power game between nation states. New mechanisms of coordination develop in various transnational policy areas, which favour communicative forms of problem-solving. This basic motive of Jürgen Habermas' discourse theory informs the central questions of this volume: How can the anarchic moment of communicative freedom be researched in international politics? Under which conditions can argumentation hold the upper hand in decision-making? And finally: How to prevent that new forms of governance undermine the establised forms of democratic coordination?

This report focuses on the prospects for a viable European public sphere (or spheres), and takes stock of the status of the EU as a rights-based post-national Union by examining the nature and character of European civil society.

These consist of: (i) a survey of how well different standards of democratic performance are met by different EU institutions; (ii) a study of different modes of inter-parliamentary cooperation between national parliaments and the European Parliament, and; (iii) studies of how institutions and politics of representation on EU matters are developing in 2004 accession states (the Czech Republic and Latvia).

lationship between social insurance mechanisms and democratic government. This should be done by means of: (i) spelling out the role played by social insurance mechanisms in forging a social identity, or we-feeling, which contributes to the actual and normative legitimacy of social institutions; (ii) empirical analysis and theoretical reconstruction of the constitutional discipline of socio-economic regulation and insurance mechanisms already existing at the EU level; and (iii) testing the coherence of the existing resource basis of the Union and its positive social-economic policies, on the one hand, and the socio-economic objectives required to reconstitute democracy at all levels of government on the other.

Research proposals should be conceptually innovative and methodologically rigorous, and should indicate how they address the RECON models. Please note that proposals can only be submitted through the European Commission's electronic submission system (EPSS) from the call launch in November.
